This is the last Will and Testament

of me ARTHUR WEGUELIN GREENE of 14 Cardigan Street, Somerset in Tasmania, Retired WHEREBY I REVOKE all former testamentary dispositions made by me and declare this to be my last Will

1. I APPOINT my daughters Audrey Winnifred Hay of 18 Colgrave Road Burnie in Tasmania and Clarice Annie Connelly of 31 Jackson Avenue Whyalla Norrie in South Australia (hereinafter called "my Trustees" which expression shall where the context so admits mean and include the trustee or trustees for the time being of this my Will) to be the executors and trustees of this my Will should my wife Clarice Emma Louisa Greene survive me for two calendar months I GIVE DEVISE AND BEQUEATH the whole of the real and personal estate of which I shall die possessed to my said wife for her own use and benefit absolutely

2. Should my said wife not survive me as aforesaid I GIVE DEVISE AND BEQUEATH the whole of the real and personal estate of which I shall die possessed to my said two daughters in equal shares.

3. I DECLARE that should either of my said daughters die before me or before attaining a vested interest leaving issue surviving to attain the age of majority such issue shall take and if more than one equally between them the share of my estate which would have been taken by his her or their parent had such parent survived me and attained a vested interest.
