The following information has been conveyed to the applicant, whose signature is appended —

1. On enlistment, airmen become subject to the Air Force Act and Air Force Regulations as amended from time to time and Orders promulgated under the authority of that Act and Regulations.
2. Enlistment will be for the duration of the war and for a period of not more than twelve months thereafter.
3. Enlistment is for service anywhere, and no guarantee can be given as to location at any time, but the wishes of personnel will be considered as far as the exigencies of the Service permit. Airmen must be prepared to serve overseas or in Australia.
4. Promotion to higher ranks, re-muster to other trades, and transfer to other units are governed by the following factors —
 - (a) the requirements of the Service;
 - (b) the existence of vacancies;
 - (c) the special qualifications of an airman for holding any position other than that to which he has been appointed.
5. Promotion, re-muster, or transfer is always by selection and cannot be claimed as a right by any airman.
6. Re-muster to another trade is subject to the applicant having passed the prescribed trade test, and subject to vacancies occurring in approved establishments.
7. The passing of an examination for promotion, or a trade test for re-muster, does not entitle the airman to immediate promotion or re-muster, as promotion is always governed by the conditions set out in paragraphs 4, 5 and 6 above.

POST-WAR SECURITY

It is desired to impress upon personnel being discharged from the R.A.A.F. the need for strict observance of security obligations which remain with them upon their return to civil life.

It is pointed out that the activities of those who are still seeking to discover our secrets have been made infinitely easier by the lowering of war-time defences such as censorship, the control of persons arriving at and leaving the country and the restrictions governing travel throughout the world. A long term policy of secrecy should be adopted in all these matters by those who return to civilian life with such information. Nor must they allow themselves to be misled by the qualified releases about such matters which are now appearing in the daily papers. The individual, whether in the Service or returning to civil life, must learn to use his discretion and must refrain from confirming, amplifying or denying either what are, or appear to be, official releases.

Finally, attention of all personnel is drawn to the fact that, whether or not they are on the point of demobilization, their responsibilities are not limited to the safeguarding of R.A.A.F. information but of all information which may affect the security of Great Britain, the U.S.A. or any other Allied power. These secrets have been shared by the Allies and the Allies have therefore a mutual responsibility to each other.
